CIRCULAR

Sub: Ceiling prices of coronary stents notified by National
Pharmaceuticals Pricing Authority (NPPA)

With reference to the above this is to inform that the Ministry of Chemicals & Fertilizers and Parliamentary Affairs, Government of India through its Letter No. 5587/M (C&F)/17 dated 11-3-2017 has conveyed the University Grants Commission, New Delhi that the recent decision of the Government to regulate the prices of coronary stents is a very important milestone in regulation of prices of drugs and medical devices, which is aimed to substantially reduce the burden on the pockets of the poor patients and their kin.

There is a very high incidence of Coronary Artery Disease (CAD) in India associated with high morbidity and mortality and coronary stent implantation is an important treatment. The Central Government has, therefore, included the same in the schedule 1 of the Drugs (Price Control) Order, 2013 on 21-12-2016, enabling National Pharmaceuticals Pricing Authority (NPPA) to regulate the prices of coronary stents and monitors their availability. NPPA, after details stakeholder consultations, notified the ceiling prices of the coronary stents on 13-2-2017 under two categories:
